UPGRADE FROM FOAL RECORDING TO PERMANENT REGISTER

Please read these rules carefully BEFORE completing the application form. Any incomplete or incorrect forms will be returned. Horse owners MUST be current financial members of the CCSHA, in order to upgrade their foal to the permanent / adult register.

IMPORTANT NOTES: Applications can be made and paid for online; please visit our website. If you complete your application online, the CCSHA will waive the processing fee, making registering both cheaper and easier.

IF YOU ARE UPGRADING A COLT / STALLION YOU MUST INCLUDE A CERTIFICATE OF BREEDING SOUNDNESS FROM A REGISTERED VETERINARIAN AND YOUR APPLICATION MUST UNDERGO CLASSIFICATION BY THE CCSHA COMMITTEE.

A. GENERAL RULES

- Fillies / colts / geldings must be upgraded to the adult / permanent register once they reach 2 years of age
- ALL adult horses MUST be microchipped and/or branded to be eligible for CCSHA registration; this includes upgrades from Foal Recordings
- If an application to upgrade is not received by the time the horse is 3 years of age, registration will be cancelled and a new application will be required
- The registration of horses with the CCSHA is for life; however the current owner(s) must remain a financial member. If the current owner's membership lapses, the registration shall be suspended
- If you wish to list a new owner on the adult / permanent registration certificate, you must complete a *Horse Transfer Application* (an additional \$35 fee applies)
- A horse's registered name can only be changed through a special application. Applications can only be made by, or with permission of, the member who originally registered the horse and must be reviewed by the CCSHA Committee. Changes involving another member's stud prefix will not be allowed under any circumstances. Requests should be made by contacting the Registrar at registrar@ccsha.com

C. STALLION REGISTRATION

- Stallions without proven Clydesdale heritage are NOT eligible for registration with the CCSHA
- ALL new stallion applications or upgrades from Foal Recordings (with proven Clydesdale heritage) MUST include their microchip number, a
 Certificate of Breeding Soundness from a registered Veterinarian and must undergo Classification by the CCSHA Committee

If your horse is required to undergo Classification, you will need to:

- 1. Complete this form (Upgrade From Foal Recording to Permanent Register)
- Submit an Application for Classification and provide a series of photographs that clearly show the confirmation of your horse. Photographs
 / video must be in colour, of good quality and clearly illustrate the Clydesdale Cross characteristics of the horse. Dark, blurry or unsuitable
 photographs / video footage will be returned and applications will be denied.
- 3. Provide a Certificate of Breeding Soundness that has been signed by a registered Veterinarian
