# **APPLICATION TO UPGRADE FROM SPORT HORSE TO STUD BOOK REGISTRATION – <u>SPECIAL MERIT</u>**

Owners of Clydesdale Crosses that do not meet the general requirements for Stud Book Registration may apply to have their horse's registration upgraded from the Sport Horse Register, under 'special merit'. If a mare / stallion is considered to be an excellent example of the breed and meet the criteria outlined below, such horses may be promoted to the Stud Book Register via special consideration of the CCSHA Committee.

In order to be eligible for upgrade, horses must meet the following criteria;

- 1. The horse must be owned by a current financial CCSHA member and appear on the Sport Horse Registry
- 2. While proof of pedigree is not required, the horse must possess the physical characteristics of a TYPICAL Clydesdale Cross
- 3. The horse must exemplify the versatility of the Clydesdale Cross, through its performance (over time), in at least one of the many fields of equitation (e.g. showing, dressage, show jumping, eventing, etc.)

### AND / OR

The progeny of the horse (a minimum of 3) must exemplify the versatility of the Clydesdale Cross, through their performance in at least one of the many fields of equitation (e.g. showing, dressage, show jumping, eventing, etc.)

- 4. The horse or its progeny must not exhibit / possess undesirable traits such as;
  - Conformation faults
  - Unsound temperament / behavioural problems (e.g. aggression, overt fear, etc.)
  - Hereditary diseases
  - Serious health issues

The fee for upgrading from the Sport Horse Register to the Stud Book Register is \$40.00
