The CCSHA invites all Clydesdale Cross and heavy horse owners, to take part in our 2017 Young Stock and Heavy Horse Show. In order to celebrate the diversity of the Clydesdale Cross and other heavy horse breeds, the CCSHA is hosting Young Stock classes for yearlings to 3 year olds, as well as great program for adult heavy breeds.

For the first time ever we are also offering limited classes for unregistered heavy horses (pure and part bred). This gives owners a chance to get out in the Show ring, meet fellow heavy horse owners, and see if they enjoy the experience, before applying for registration with their applicable breed societies.

Like all CCSHA events, we offer a relaxed and supportive environment that caters for complete beginners, right through to experienced show handlers. It does not matter if you and your horse have never competed before; there will be plenty of assistance on the day and people to cheer you on. Feel free to go all out in your turnout gear or bring your horse with mane, tail and feather flying.

Catering will be available on the day and well-priced camping and stables are available onsite for those who wish to stay over.

Competitors **MUST** be current financial members of their own breed society and horses **MUST** be registered (excluding Unregistered Heavy Horse classes). Proof must be provided with your entry form or your entries will not be accepted. CCSHA Members may nominate a handler / rider to compete with their horse for a fee of \$10.

Classes may be combined / divided at the discretion of Event Officials.

Young Stock MUST be 3 years of age and under, as determined by the 01.08.17.

Pre-entries are charged at \$5.00 per class

CCSHA Members are eligible to pre-purchase a Show Pass for \$25 (unlimited classes)

Facility fee of \$10 per horse is charged by the venue (discounts available for multiple horses)

Entries are accepted on the day at a cost of \$8.00 per class or \$35 for a Show Pass (CCSHA members only)

Pre-entries are welcomed until Sunday 3rd September, 2017

GUIDELINES AND RULES FOR COMPETITORS

GENERAL INFORMATION

- Competitors **MUST** be current financial members of your society and horses **MUST** be registered with that society (excluding Draught Horse classes). A copy of your membership card (or similar), as well as your horse's registration certificate, **MUST** be sent in with all pre-paid entries. If you are entering on the day, proof must be presented to the Event Secretary
- CCSHA events are dog-free zones, so please leave your pets at home
- The Event Secretary will be available from 8am for entries, membership applications and horse registrations; however this will exclude participants from qualifying for the pre-entry discount for classes
- CCSHA Membership and Horse Registrations must be completed prior to the Event and will NOT be accepted on the day
- A First Aid representative will be on hand during the Event for any accidents or injuries that may occur
- Please respect the grounds, clean up after yourself and follow Elmore Equestrian Park's guidelines for rubbish and manure disposal
- Show entries that have not been paid in full, will not be accepted
- NO SMOKING IN VENUE OR AROUND ENTRANCE TO VENUE
- Competitors may enter the venue through Rosaia 4 Gate (fourth) gate in Rosaia Road from Midland Highway
- Please keep the gate closed at all times
- CCSHA registered horses are eligible to accumulate Performance Award Points. Please ensure that you bring your Performance Award form so the Event Secretary can sign it on the day
- All horse owners are required to provide a Property Identification Code (PIC) relating to the property where the horse is kept. PICs are a new requirement for all properties housing livestock and is an initiative to help trace and prevent the spread of disease. If you do have not yet applied for your PIC please go to <http://agriculture.vic.gov.au/agriculture/farm-management/national-livestock-identification-system/property-identification-code/livestock-property-identification-codes>. Applications are free and can be done online
- In the case of adverse weather or any unforeseen circumstances, the Committee Reserve the right to alter the program and / or postpone or cancel the Event
- Entry fees are ONLY refundable in extenuating circumstances (e.g. injuries or illness). Competitors may apply for a refund in writing (secretary@ccsha.com) and MUST supply a medical or veterinary certificate to substantiate their claim. An administration fee of \$10 will be payable by riders / handlers applying for a refund

CAMPING AND ACCOMMODATION

- Camping **MUST** be booked with and fees paid directly to Elmore Equestrian Park (EEP). The CCSHA is unable to accept fees or make bookings on your behalf. Please complete the form attached and forward directly to EEP
- Powered camping sites are available at a cost of \$20.00 per night and are located on adjacent to the stables
- Non-powered camping sites are available at a cost of \$15.00 per night and are located adjacent to the day yards
- No horses are to be tied up in the powered camping area
- **Horse manure in camping area MUST be cleaned up**

STABLES

- Stables are available for \$25.00 per night and **MUST** be booked with and fees paid directly to EEP. The CCSHA is unable to accept fees or make bookings on your behalf. Please complete the form attached and forward directly to EEP
- Bedding is NOT included in the stable price and can be ordered through EEP. Straw can be purchased at a cost of \$10 per bale (delivered to your stable). Shavings can be purchased at a cost of \$32 per stable (delivered to your stable)
- The stable next to your horse may be booked to use as a tack room (pending availability) for \$15 per event
- Competitors will be advised of their allocated stable numbers prior to the event and are not permitted to swap stables without permission from EEP
- All stables must be thoroughly cleaned before you leave. Stables that have not been cleaned correctly will incur a fee of \$50
- Cleaning of stables can be pre-booked at a cost of \$30 per stable
- Painting of horse's hooves is strictly not permitted on any concreted areas, including the stables. There are mats available in the stable pavilion for competitors use

- Competitors who have not booked stables are required to park their float in the day yard area

RULES FOR HORSES

- In order to be eligible to enter Young Stock classes, horses **MUST** be 3 years of age and under, as at 01.08.17. See below

AGE	DATE OF BIRTH
Yearling	Born on or after 1 st August 2016 and on or before 31 st July 2017
2 year old	Born on or after 1 st August 2015 and on or before 31 st July 2016
3 year old	Born on or after 1 st August 2014 and on or before 31 st July 2015
4 year old and over	Born on or before 31 st July 2014

- Horses will be allocated with an exhibit number and this must be clearly displayed throughout the event (i.e. chest number holder, number displayed on halter / bridle, handler to wear number, etc.)
- Young stock must be weaned and / or compete in the ring on their own. No Mares or other companions may enter the ring
- Young stock to be shown according to their breed standard
- Plaiting is optional. All horses should be presented in a neat, clean and tidy manner
- Under no circumstances are horses to be tied to the rails of the arena
- Young Stock that are deemed to be risk to other exhibits or exhibitors will be asked to leave the arena and no refund on entries will be provided
- No horse food or water is permitted in the arena.
- Horses are not permitted to be tied to floats unless they are fully supervised
- No lunging is permitted on any grass area
- Wash bays are available for use (cold water only) and must be kept clean at all times. Please ensure you remove any manure and be respectful of other competitors

Stallions

- Colts under 2 years of age are NOT permitted to be handled by those under the age of 15 years
- Stallions / colts 2 years & over, MUST be handled and ridden by a person over 18 years and over and must be bitted at all time while in the arena / ring
- Stallions should wear official green 'discs' at all times whilst at the venue. These discs are to be worn on both sides of head collars and bridles or on some part of the horse on both sides to identify to others that the horse is a stallion
- Colts / stallions must be under effective control AT ALL TIMES. Any colt / stallion that presents a danger to other horses or people, will be disqualified from the Event and may be asked to leave the premises
- All stallions must be suitably restrained while at floats. They may be double tied (with a suitable headstall, neck collar and 2 lead ropes), hobbled and tied up or contained in a stable
- Stallions must wear a headstall at all times when not bridled (i.e. when stabled). This ensures that your horse can easily be caught, should it escape

RULES FOR COMPETITORS

- All competitors compete at their own risk
- All competitors who are NOT current financial members of Equestrian Australia MUST sign the Waiver attached
- The Committee reserves the right to refuse entry to anyone that is suspected of being under the influence of Drugs or Alcohol
- The Judge's decision will be final and Judges must not be approached on the day of the show by competitors or their associates
- No exhibitor may show:
 - An exhibit bred by or leased from the judge or their family in the ring which the judge is officiating
 - An exhibit purchased from the judge or their family in the ring in which the judge is officiating, until after a period of 12 months

- An exhibit in a class under the judge who has produced an animal for that exhibitor in the previous 12 months
- Once a class has commenced, no exhibit may leave the ring unless instructed to do so by the ring officials
- There is to be no change of handler once the class has commenced, without the permission of the Judge
- All competitors must wear suitable footwear and clothing. No open toe shoes or ripped clothes allowed
- Competitors who fail to abide by these rules will be asked to leave the ring / event
- Bad sportsmanship and bullying will not be tolerated by the CCSHA and may result in disciplinary action (e.g. being asked to leave the ring, disqualification from the event, cancellation of membership)

Protests

- An exhibitor / competitor may protest against an award won by an exhibitor / competitor in the same class alleging infringement of the rules or ineligibility
- Protests must be made in writing and lodged with the Event Secretary, within 30 minutes after the conclusion of the class
- Such protest shall be accompanied by a deposit of \$50, which may be forfeited to the CCSHA if the protest is found to be unfounded or frivolous
- Protests will be considered by CCSHA / Event Officials and the decision shall be final

Junior Competitors

- All competitors under the age of 16 years must wear approved helmets (AS/NZS 3838, EN1384, ASTN F1163) when participating in led and long reining classes
- All handlers under 10 years of age must be accompanied by an adult while in the ring
- All handlers between 10 and 13 years must have a supervising adult present at the side of the ring who is able to assist, should they need help / get into trouble
- The Committee Reserve the right to request direct parental / adult supervision should they deem it necessary

Handlers

- A CCSHA member is permitted to nominate a non-member to show their horse, providing the horse owner is a current financial member and the horse is registered with the CCSHA
- Handlers are required to pay an additional \$10 fee on top of the class or Show pass costs
- Handlers are NOT eligible to enter handler classes
- Handlers are bound by the same rules as CCSHA Members
