#### **GUIDELINES AND RULES FOR COMPETITORS**

#### **GENERAL INFORMATION**

- Riders/Competitors MUST be current financial members of the CCSHA and horses MUST also be registered
- All competitors MUST PRE-ENTER this event. Entries will NOT be accepted on the day
- The facility fee introduced by Equestrian Victoria is \$10 per horse, per ring. If you are competing on multiple days and/or in more than one breed ring you will be required to pay this fee to each Association.
- Catering will be provided during the Event
- First Aid representatives will be on hand over the weekend for any accidents or injuries that may occur
- A professional photographer will be present at the Event and competitors will be provided with the opportunity to purchase photographs directly from the supplier. CCSHA representatives will also be taking photographs on the day which may be displayed on the CCSHA Facebook page or website
- All horses competing at the Event are eligible to accumulate Performance Award and Annual High Point Award Points. Please ensure that you bring your
  paper work with you so the Event Secretary can sign it on the day
- In the case of adverse weather or any unforeseen circumstances, the Committee Reserve the right to alter the program and / or postpone or cancel the Event
- Entry fees are ONLY refundable in extenuating circumstances (e.g. injuries or illness). Competitors may apply for a refund in writing (secretary@ccsha.com)
  and MUST supply a medical or veterinary certificate to substantiate their claim. An administration fee of \$10 will be payable by riders / handlers applying for a
  refund

#### WERRIBEE PARK RISK MANAGEMENT CONDITIONS

- Werribee Park National Equestrian Centre Committee of Management considers it a privilege that you are allowed to bring your dog to this venue. We insist
  you keep your dog under effective control and on a leash at all times.
- 2. Approved Safety Helmets must be worn at all times when riding
- 3. Cross Country obstacles must not be jumped/used unless a non-riding level one NCAS coach is present.
- 4. Riding of horses bareback is prohibited
- 5. Riding of rugged and/or unbridled horses is prohibited
- 6. Any person may lead a maximum of two horses while mounted
- 7. Stallions must at all times be in the control of a person aged eighteen years or more
- 8. Horses are not permitted within/upon the quadrangle (between the barn & Indoor 1)
- 9. Horses are not permitted near pedestrian door ways
- 10. Straw bedding is not permitted on the venue, wood shaving type bedding is accepted only
- 11. Bicycles are not permitted in the Indoor Arenas or any stable block. Approved helmets must be worn at all times.
- 12. Bicycles are not permitted near doors designated as public entrances or exits
- 13. Motor Cyclist riders must wear approved safety helmets and hold the appropriate licence
- 14. Speed limits must be adhered to at all times, the speed limit at WPNEC is 10km p/h
- 15. Power leads must not be on the ground or over roadways
- 16. Construction of portable/tape yards is prohibited
- 17. Alcohol must not be consumed in the Indoor Arenas, unless purchased from the licensed bar located in Indoor Arena No 1
- 18. Please observe all signs at the venue
- 19. Horses must be tied in a safe manner. Horses must not be tied to unattached floats, wheelie bins etc.
- 20. No infrastructure to be erected on WPNEC Grounds without written approval by management prior to event.
- 21. Entry and Exit doors to Indoors Arenas are not be obstructed at any time.
- 22. Every event to book at WPNEC must provide their own first aid officials.
- 23. Report any incidents, damages or safety concerns to WPNEC management immediately.
- 24. Dogs are not permitted on the Cross Country Course when in use.
- 25. Please call WPNEC Management should you require any assistance with ANY Issue
- 26. Users who do not comply with these guidelines may be refused future use of WPNEC

#### **CAMPING AND ACCOMMODATION**

- All camping and stable bookings must be made directly with Werribee Equestrian Park (<a href="http://wpnec.com.au/bookings/">http://wpnec.com.au/bookings/</a>) and close 48hrs prior to the start of the event
- Stables: A to E blocks = \$37 per night, F block (barn) = \$49 per night, bedding can be booked by calling 97417672

- Camping / leaving vehicle overnight: \$20 powered site, \$10 unpowered
- Werribee Park National Equestrian Centre reserves the right to change your stable/yard booking at all times. You will be notified of any changes made by our
  office. Stable lists will be left in the window of the WPNEC Office as of close of business on the day prior to an event
- All stables not prepaid to be cleaned are to be left clean at the end of your stay. Stables not cleaned will be charged \$30
- The only bedding allowed at WPNEC is shavings, in both the stables and yards. Straw is not permitted. Use of any other product will incur a \$30 removal fee

#### **WASH BAYS**

- For anyone wishing to wash their horses, there are wash bays available
- Please respect the grounds and other members and don't leave a mess for others to clean up

#### **COMPETITOR RELATED RULES**

- All competitors compete at their own risk
- All competitors who are NOT current financial members of Equestrian Australia MUST sign the Waiver attached
- . The Committee reserves the right to refuse entry to anyone that is suspected of being under the influence of Drugs or Alcohol
- The Judge's decision will be final and Judges must not be approached on the day of the show by competitors or their associates
- No exhibitor may show:
  - An exhibit bred by or leased from the judge or their family in the ring which the judge is officiating
  - An exhibit purchased from the judge or their family in the ring in which the judge is officiating, until after a period of 12 months
  - An exhibit in a class under the judge who has produced an animal for that exhibitor in the previous 12 months
- Once a class has commenced, no exhibit may leave the ring unless instructed to do so by the ring officials
- There is to be no change of handler /rider once the class has commenced, without the permission of the Judge
- All competitors must wear suitable footwear and clothing. No open toe shoes allowed
- Bad sportsmanship and bullying will not be tolerated by the CCSHA and may result in disciplinary action (e.g. being asked to leave the ring, disqualification from the event, cancellation of membership)
- All ridden competitors must wear helmets that meet the current EA Regulations (AS/NZS 3838 (2006 onward) provided they are SAI Global marked; ARB
  HS 2012 provided they are SAI Global marked; ASTMF1163 (2004a or 04a onward) provided they are SEI marked; SNELL E2001; PAS015 (1998 or
  2011) provided they are BSI Kitemarked; VGI (01.040: 2014-12) with or without BSI Kitemark).
- Restraining harness on helmets must be secured and fastened at all times whilst mounted
- Competitors who fail to abide by these rules will be asked the leave the ring / event

#### Junior Competitors

- All competitors under the age of 12 years must wear approved helmets (AS/NZS 3838, EN1384, ASTN F1163) when participating in led and long reining classes
- All handlers under 10 years of age must be accompanied by an adult while in the ring
- All handlers between 10 and 16 years must have a supervising adult present at the side of the ring who is able to assist, should they need help / get into
  trouble
- The Committee Reserve the right to request direct parental / adult supervision should they deem it necessary

#### **HORSE RELATED RULES**

- All horse and rider / handler combinations will be allocated an individual number which needs to be clearly displayed on each day of the competition.
   Competitors will need to source their own number holder which may be attached to the bridle, saddle blanket, breast plate or worn on the rider / handler. If riders / handlers are competing more than one horse, they must ensure that they swap numbers as they swap mounts. To avoid confusion, we recommend that you display your number on your horse, rather than the rider / handler
- All ridden mounts must be bitted, no bitless bridles or halters will be allowed in the ridden classes. This is for insurance reasons
- No horses under the age of 3 years will be allowed to be ridden, however you are welcome to participate in the led classes

#### Stallions

- Colts under 2 years of age are NOT permitted to be handled by those under the age of 15 years
- . Stallions / colts 2 years & over, MUST be handled and ridden by a person over 18 years and over and must be bitted at all time while in the arena / ring
- Stallions should wear official green 'discs' at all times whilst at the venue. These discs are to be worn on both sides of head collars and bridles or on some part of the horse on both sides to identify to others that the horse is a stallion
- Colts / stallions must be under effective control AT ALL TIMES. Any colt / stallion that presents a danger to other horses or people, will be disqualified
  from the Event and may be asked to leave the premises

- All stallions must be suitably restrained while at floats. They may be double tied (with a suitable headstall, neck collar and 2 lead ropes), hobbled and tied
  up or contained in a stable
- Stallions must wear a headstall at all times when not bridled (i.e. when stabled). This ensures that your horse can easily be caught, should it escape

#### Young Stock

- · Young Stock must be weaned and / or compete in the ring on their own. No Mares or other companions may enter the ring
- Plaiting is optional. Naturally presented young stock should be neat, clean and tidy
- All colts 2 years and over must be bitted (or chain) in the ring and handled by persons over 18 years of age
- Young Stock that are deemed to be risk to other exhibits or exhibitors will be asked to leave the arena and no refund on entries will be provided
